About

This indicator is the percentage of citizens who reported experiencing any financial barrier in getting the health care they needed in the last 12 months, based on their responses to 4 individual questions related to costs.

Calculations

This indicator combines the responses to the following 4 individual questions related to costs: Now think of any difficulties you may have experienced in getting the health care you needed in the last 12 months. In the last 12 months, did you: 'c) Find the cost for ambulance services too high (yes/no)', 'h) Not fill a prescription for medicine, or skip doses of your medicine because of the cost (yes/no)', 'g) Skip a medical test, treatment, or follow-up that was recommended by a doctor because of the cost (yes/no)' and 'i) Skip dental care or dental checkups because of the cost (yes/no)'. This indicator is calculated by dividing the number of respondents who answered 'yes' to at least 1 of these individual questions by the total number of respondents.

Notes

The 2020 edition of the Primary Health Survey (PHS) was conducted during the COVID-19 pandemic. While the pandemic did not influence the survey's response rate, NBHC had to assess the impact of surveying during the pandemic. Accordingly, advanced statistical analyses were performed to allow for comparison between the results obtained in 2020 and those obtained in previous PHS cycles. Despite these analyses, users are advised to use the PHS 2020 data with caution, especially when creating estimates for small sub-populations or when comparing it to other PHS editions.
