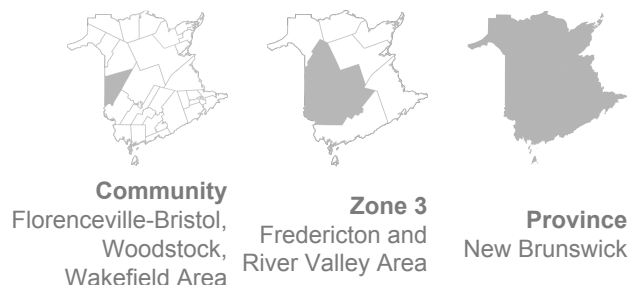

# About this Table
